# TERMS & CONDITIONS

1. This document relates to any applicant registering with Athletics Victoria Inc. for the period 1-4-07 to 31-03-08 (inclusive).
2. Hereon "AV" means Athletics Victoria Inc.
3. I hereby make application for membership of AV with the Club listed on the registration form and declare that I am eligible to participate in competition according to the eligibility laws set down by the By Laws of Athletics Australia. I agree to abide by all the Rules and By Laws of AV, Memorandums, Articles and By Laws of Athletics Australia and Constitution and Rules of the International Association of Athletics Federation as amended from time to time.
4. The parent/guardian is responsible for the applicant & the applicant's adherence to this document if the applicant is under 18 years.
5. I acknowledge and consent to photographs and electronic images being taken of me during my participation in AV events by an official representative of AV. I acknowledge and agree that such photographs and electronic images are owned by AV and that AV may use the photographs for promotional or other purposes without my further consent being necessary. Further, I consent to AV using my name, image, likeness and also my performance in any AV Events, at any time, by any form of media, to promote the Event and AV. AV is not responsible for photographs and electronic images taken by persons who are not an official representative of AV.
6. I understand that these rules are subject to change at AV's discretion.

8. SIGNATURES - I understand that registrations will be refused if the registration form is not signed by both the applicant and club secretary/registrar.

## FEE PAYMENT

- 9.1 I agree to provide payment for the charges outlined on this form.
- 9.2 I agree to provide payment for any outstanding charges outlined by my club at or before submission of this form to AV.
- 9.3 I understand that failure to do so may result in disqualification from competitions.

## 10. CHARGES:

### 10.1 ATHLETE

- 10.1.1 An athlete is allowed to compete at AV events according to the various rules and policies relating to all AV competitions.
- 10.1.2 Athlete classifications for fee purposes are:
  - ♦ UNDER 16 ATHLETE - for people born 1-1-1992 to 31-3-2003 (inclusive)
  - ♦ UNDER 20 ATHLETE - for people born 1-1-1988 to 31-12-1991 (inclusive)
  - ♦ OPEN - all other athletes

### 10.2 OFFICIAL

- 10.2.1 Any person may register as an official, provided they have not been explicitly excluded from doing so, and provided they do not present a risk to other members of the association.
- 10.2.2 To act as an official at an AV event, a person must:
  - 10.2.2.1 have registered as an official; and
  - 10.2.2.2 consent to undertake a national police record check through AV at AV's expense; and
  - 10.2.2.3 have the necessary qualifications for acting as an official for that particular event.

### 10.3 COACH

- 10.3.1 Any person may register as a coach, provided they have not been explicitly excluded from doing so, and provided they consent to undertake a national police record check through AV at their own expense (at a discounted volunteer fee).
- 10.3.2 Registering as a coach provides privileges such as:
  - 10.3.2.1 A short listing on the AV website, if requested.
  - 10.3.2.2 Free entry into Open and Underage State Championships.

### 10.4 ASSOCIATE

- 10.4.1 Associate members are people who would like to contribute to the sport in ways other than listed above.

### 10.5 DUAL FIRST CLAIM:

- 10.5.1 Dual First Claim registration entitles an athlete to nominate one club as his/her first claim club for the 2007 Winter Season or the 2007/08 Summer Season.
- 10.5.2 Dual First Claim membership is valid for one year and terminates after 31/3/2008. Registration then reverts to the original first claim club.
- 10.5.3 Dual First Claim applications must be made on the AV registration form and incurs an additional fee.
- 10.5.4 Dual First Claim registration must be completed by:
  - ♦ 1/6/2007 - For winter season
  - ♦ 1/11/2008 - For summer season
- 10.5.5 Please ensure all parties have completed the form before lodging with AV (including signatures from each of the club registrars).

### 10.6 TRANSFER

- 10.6.1 Any member registered with an AV club at any time in the period 1-4-05 to 31-3-07 (inclusive) who is applying to register with a different club is deemed a "Transfer" and must meet the following requirements:
- 10.6.2 A completed transfer form from the applicant's present club must accompany the application.
- 10.6.3 Any person who has been refused a clearance by an Affiliate Member or whose application for a clearance has not been dealt with within 21 days of lodging their application may lodge an appeal with the Board.
- 10.6.4 The appropriate fee and either a letter of refusal of clearance by the Club concerned or evidence that the application was made to the Club 21 days prior to the lodgment of the claim must accompany any such appeal.
- 10.6.5 Applications for a transfer of membership to compete for an Affiliate Member must be completed by:
  - ♦ 1/6/2007 - For Winter Season
  - ♦ 1/12/2007 - For Summer Season

## 11. DISCOUNTS

### 11.1 VAL - VICTORIAN ATHLETIC LEAGUE

- ♦ Athletes must register with both Associations at the same time
- ♦ AV members Open Metro Members deduct \$30 off normal, U20 Metro Members \$25 off normal, U16 Metro Members \$20 off
- ♦ AV members Open Country Members deduct \$20 off normal, U20 Country Members \$15 off normal, U16 Country Members \$10 off
- ♦ Discount only applicable to VAL Premium category

### 11.2 VLAA - VICTORIAN LITTLE ATHLETICS ASSOCIATION

- ♦ Registered Little Athletes in the U13 - U15 age groups only
- ♦ Qualification dates are birthdays between 1-10-92 & 30-9-95 (inclusive)
- ♦ A confirmation letter must be supplied by first time members

### 11.3 VMA - VICTORIAN MASTERS ATHLETICS

- ♦ One Category only & AV members must be financial members of Victorian Masters Athletics at 1-1-07
- ♦ Open Metro Members deduct \$30 Open Country Members deduct \$20

### 11.3 PS - PARTNER SPORT

- ♦ One Category only & AV members must be financial members of Triathlon Victoria, Hockey Victoria or AFL Victoria (formerly Football Victoria) at time of AV registration. A photocopy of current membership card or letter from PS club secretary on letterhead but be supplied with registration form, otherwise discount will not be processed.
- ♦ Other partner sports may be added at any time, please see [www.athsvic.org.au](http://www.athsvic.org.au) to view all partner sports.
- ♦ Open Metro Members deduct \$30 Open Country Members deduct \$20

### 11.4 FAMILY DISCOUNT:

- 11.4.1 A Family is defined as a minimum of 1 Adult & 2 Children U18 yrs as of 1-1-07.
- 11.4.2 Family members must reside at the same address
- 11.4.3 Family Members must register at the same time
- 11.4.4 This discount CANNOT be applied if any person in the family registers as a Coach or Official, or applies for Youth Athlete, VMA, VAL, PS, or VLAA discounts.
- 11.4.5 Discount is multiplied by the number of Family Members & subtracted from the total amount due.
